Tuition fees listed below are reflective of our nationally accredited program and are comparable to local school programs. We are also privately funded and maintain our programs solely through tuition.

### **9 Monthly Payments of \$1,100.00**

\* Full tuition will be calculated for children enrolling after August 27, 2018 and pro-rated at \$60 per day for the first month/payment period.

## *Before & After School Program*

We offer a Before & After School Program for your child enrolled in our Kindergarten & Transitional Kindergarten Academy while class is in session. Your child will be with their same age group for the program hours listed below.

\* \$25 for our Before and/or After School Program from 7:00 a.m. - 9:00 a.m. & 2:30 p.m. - 6:00 pm.

\* \$60 per day scheduled for intersession days (7:00a.m. -6:00p.m.)

**ADMISSION POLICY:** Enrollment is open to all boys and girls of all races, religions, ethnic backgrounds, and those with special needs who are able to actively participate and benefit from school activities and demonstrate developmental, social and academic readiness skills for necessary for classroom and personal success.

**ENRICHMENT PROGRAMS:** A variety of on-site enrichment classes are offered throughout the year. These may include ballet, tap and jazz dance, foreign language, gymnastics, theater, music and movement, sports and more. Class schedules and fee schedules are distributed periodically.

**HOLIDAYS:** Winter Break is December 17 - January 1. Spring Break is April 15 - 19. Intersession is available during these Kindergarten breaks. For other campus closures, please consult the holiday schedule for specifics.

**INTERSESSION:** Intersession is available during Kindergarten's winter and spring recesses and parent-teacher conference day when the campus is otherwise open.

**ENRICHMENT PROGRAMS:** A variety of on-site enrichment classes are offered throughout the year. These may include ballet, tap and jazz dance, foreign language, gymnastics, theater, music and movement, sports and more. Class schedules and fee schedules are distributed periodically.

**ENROLLMENT CONFIRMATION:** A deposit of \$200.00 is due upon acceptance into the Kindergarten program. ***This non-refundable deposit is applied to the May/June Tuition payment for children enrolled the entire school year provided the school account is current.***

**REGISTRATION FEE:** A one-time registration fee of \$50.00 is due upon enrollment and is non-refundable for any reason. This fee is waived for currently enrolled LCVPK students.

**ANNUAL CURRICULUM & EQUIPMENT FEE:** A fee of \$300.00 contributes to classroom curriculum materials, equipment and supplies for the school year. ***This fee is non-refundable.*** Children will also be given a supply list.

**EARLY DROP OFF AND LATE PICK UP:** Kindergarten and Transitional Kindergarten Academy begins at 9:00a.m. and ends at 2:30 p.m. A fee of \$25 per half hour or any portion thereof is charged for ***unscheduled*** attendance before or after class sessions.

**AFTER HOURS PICK UP (After School Closure)** is billed at the rate of \$35.00 per quarter hour or any portion thereof regardless of cause.

**TUITION PAYMENTS :** Annual Tuition is divided into 9 payments of \$1,100.00. Annual Before and After School payments are divided into 9 payments of \$150.00. Students beginning after August 27 will have tuition pro-rated at a cost of \$60 per day for the first month/payment period of attendance. Before and After School Tuition is not pro-rated (See reverse side for tuition schedule and options). Checks must be received by dates listed below, however, they may be postdated for the first of the month to avoid a late fee.

**OCCASIONAL BEFORE AND AFTER SCHOOL AND INTERSESSION PAYMENTS:** Due on date of enrollment confirmation.

**LATE PAYMENTS:** Payments made after the due date of each month are late and a \$35.00 late fee will be applied to accounts with outstanding balances. A \$50.00 fee will be charge for accounts 3 to 5 days past due. A \$75.00 fee will be charged for accounts more than 5 days past due, up to a maximum of \$75.00 per current month. Check, Cash or Credit Card/PayPal payments are accepted.

**RETURNED CHECK FEE:** A fee of \$35.00 is charged for returned checks regardless of cause.

**WITHDRAWAL & DISMISSAL:** ***La Costa Valley Preschool and Kindergarten*** reserves the right to terminate enrollment for safety, non-payment, or other related reasons at any time. A two week notification will be given unless circumstances prohibit extension of services as determined by ***La Costa Valley Preschool and Kindergarten*** staff members.
